





### **Definition of an EAP**

A work sponsored program for employees and their dependents that offers free and confidential assessments, short-term counseling, and referrals to outside agencies. Included as a free benefit in health care.

An EAP can help resolve many issues related to:

- Stress Management
- Anxiety
- Depression
- Work/life balance
- Relationship issues
- Alcohol and drug problems





# Confidentiality

No confidential information shared with an EAP can be released without your written consent. Exceptions include information in accordance with state laws when there is a serious risk of harm to self or others, elder and/or child abuse.

# **Privacy**

Treatment by EAP counselors is covered under Federal HIPAA regulations. Modern Assistance takes every precaution to ensure your confidential information if protected.
